New Applicant Checklist

There is a 2-step process to receive a North Dakota CTE Initial Teaching License. You need to apply with Education Standards & Practices Board (ESPB) and also apply with North Dakota Department of Career & Technical Education. They are two separate agencies.

To receive an initial 2-year teaching license with a CTE Endorsement, you must first be offered a teaching position and then complete the following:

	Online application: ND Teach (You will log in using your ND State Login. If you do not have one, click "Register Now" to obtain one.)
	Fingerprinting and Background Check through ESPB
	Complete Mandated Reporter Training (new initial license applications on or after August 1, 2025)
	Pay Appropriate Fees through ESPB

With CTE	
	Complete Application for Secondary Teaching License/Endorsement Application (SFN 61262).
	Upload copies of current training/certification/license required for the occupational field you teach in (Ex.: ASE, Nursing, etc.) to the application.
	Upload copies of college transcripts. Unofficial copies are sufficient if it shows credits earned.
	Upload Occupational Work Experience Verification Form (SFN 50986). <i>Within the last 8 years verify 8,000 hours of work experience in the occupational field you teach. Applicant completed top portion of the form and your previous employer(s) complete the bottom.</i>

All first-time applicants receive an initial 2-year license which allows time to complete the required training to gain classroom management skills and other valuable new educator information. Valley City State University offers a Transition to Teaching course that is sponsored by the North Dakota Department of Career & Technical Education that will fulfill this requirement. Through our partnership with VCSU, credit hours are offered at a reduced cost, but the cost of this program is your responsibility.

Please keep in mind that you will need to provide the following when your initial license expires:

- Verification that you have completed Transition to Teaching (Clinical Practice and Edu 250 Course)
- Verify 18 months of consecutive full-time teaching.

For teachers teaching in schools where your program is approved by and receives funds from North Dakota Department of Career & Technical Education, the following courses (or course equivalent) must be completed within the first three years of teaching. This is NOT a requirement for teacher licensure but will be required for continued program approval at your school.

- History and Philosophy of CTE
- Managing Student Organizations (CTSO)

Renewal Application Checklist

There is a 2-step process to renew your CTE Initial teaching license to a CTE 5-year teaching license. You need to apply with Education Standards & Practices Board (ESPB) and apply with North Dakota Department of Career & Technical Education. We are two separate agencies.

To receive a CTE 5-year teaching license with a CTE Endorsement, please complete the following:

Secondary Teaching License/Endorsement Renewal Application (SFN 51688)
First Renewal (moving from Initial 2-year to CTE 5-year only): Upload copy of a college transcript showing completion of the Transition to Teaching (Clinical Practice) and Edu 250 (Intro to Education) Course. Unofficial copies are sufficient if it shows credits earned.
Subsequent Renewals (only): Upload copies of current training/certification/license required for the occupational field you teach showing the needed 64 hours professional development (Ex.: ASE, Nursing, etc.) to the application.
Subsequent Renewals (only): Upload copies of your college transcript(s) showing 6 semester credits. An unofficial copy is sufficient if it the required credit hours.

Please keep in mind that you will need to provide the following when your 5-year license expires:

- Verify 64 hours of professional development
- Verify 6 college credits

Endorsement Application Checklist

There is a 2-step process to apply for an initial or renewal CTE Endorsement. You need to apply with Education Standards & Practices Board (ESPB) and apply to the North Dakota Department of Career & Technical Education. We are two separate agencies.

Endorsement expiration dates align with the expiration date of a CTE, Alternate or Regular teaching license and are valid for five years. Endorsements do not qualify for lifetime licensure and will continue to expire every five years when added to a lifetime teaching license.
