Scholarship Available to CTE Students

The Reuben T. Guenthner Scholarship is given in memory of Reuben T. Guenthner, a leader in Career and Technical Education (CTE) in both the state and nation. Mr. Guenthner was first a CTE student, then a secondary CTE instructor, a local administrator supportive of CTE programs, and finally a member of the North Dakota Department of Career and Technical Education from 1968 to 1995. Mr. Guenthner was appointed to the National Advisory Council on Career Education by President Reagan in 1982. At the time of his retirement in 1995, Mr. Guenthner was the North Dakota State Director of Career and Technical Education. One scholarship in the amount of \$500 will be awarded in May 2023.


The Ag. Mechanics classes in **Lisbon** have been putting their concrete knowledge into creating cement monuments that will be placed out at Oakwood Cemetery!



Students from Minto High School participated in the Emerging Leaders Competition at Valley City State University for business and marketing students in January. Minto had 27 students participating and 13 of those students received medals for their performance. This prepares students for job interviews, problem solving, communications, and more.



Management students from Minot High School assisted at the Marketplace for Kids event held on Minot State University Campus in December. More than 20 students assisted with registration room monitors and presented on soft skills. Marketplace for Kids is held throughout the state which provide learning opportunities for students in grades four, five, and six.



We asked Annie Retka about the Entrepreneurship Competition

Tell me about your Entrepreneurship Project involving students and the community.

My Entrepreneurship class participated in the Junior Achievement program during the first semester. The class split into 4 groups to create and launch their businesses. Throughout the semester, we had a Junior Achievement (JA) Volunteer who is a community member come into the classroom and help present the lessons and offer their business knowledge to the students while they students created their businesses. Students produced, launched, and sold their products, some even making a profit! The students submitted a business plan and commercial that they produced on Monday, December 5th to the panel of Junior Achievement judges to compete against 30 other area high schools in Fargo/West Fargo and surrounding schools. The judges only advanced 6 teams and Sheyenne High School took 3 of those 6 spots! They advanced to the next round where they had the opportunity to compete for scholarship money with \$1,000 each for the top prize!

What was the process for the competition?

On December 15th they competed virtually against the other advancing businesses/teams. They presented their businesses to a panel of judges comprised of community members and then had an interview following their presentation. I am excited to announce that 2 of the 3 businesses that Sheyenne High School that advanced took first and second place.

What was the Prize?

The first-place members each received \$1,000 scholarship and the second place members will each receive a \$500 scholarship. Additionally, the team that placed first is advancing to compete in Minneapolis in the spring where they are competing for a chance to go to Washington, D.C.

Who won the competition?

The business team that placed first is called *The Plains Brand* and they created a t-shirt that represents the Midwest culture through art and they make donations back to the Plains Art Museum who supports local artists.



The business team that placed second is called Branded Jewelry and they created charm bracelets and necklaces to go along with life's special moments.

To approve opportunities, go to the Work-based Learning tab in the Professional Center. Under each of the subtabs Organizations and Opportunities go to Status column. If the status is "Needs Review" change to "Active." Students will be able to review and apply at that point. We recommend checking in once a week to see if new opportunities are there for you to approve.

North Dakota Advisors had the opportunity to take part in a new pilot comprehensive chapter training program sponsored by SkillsUSA. Being one of six states in the country to participate, this unique professional development training provided the opportunity for SkillsUSA Advisors, seasoned and new, to learn what SkillsUSA is and how it will help their classroom and local chapters. Networking, experiential activities, and fantastic resources allowed for advisors to start planning how to integrate SkillsUSA into everything they do.

The first training consisted of one in-person and three virtual sessions covering what a CTSO is, what is SkillsUSA, the SkillsUSA Framework, and integration of the SkillsUSA Framework. Advisors were taken through resources and activities that they could implement into their classrooms and chapter meetings. The second in-person training



expanded on those topics. Advisors participated in a chapter simulation experience where they continued networking, took a deeper dive into how a comprehensive chapter functions, and learned how to use SkillsUSA resources to build their local chapters. Not only were advisors given the tools to support their successful chapters, but they also demonstrated the implementation of the resources into classroom and chapter activities.



By completing activities and certifications in and outside of the training sessions, participating SkillsUSA North Dakota advisors will be among the first in the nation to be Nationally Recognized as a SkillsUSA Certified Advisors and have the opportunity to attend the new Advisor Summit held in Atlanta, GA this June.

Writing A Strong Award Nomination

How you represent a candidate's accomplishments and qualities in a nomination is critical in making the best impression on judges. Here are some tips for making the most out of your nomination:

Persuasiveness & Impact

Does your nomination address the criteria for the award? Looking at the rubric will give you an idea of what areas are most important.

Are you being descriptive enough with your candidate's achievements? How did the nominee contribute to the goal, and what were the end results? Include measurable outcomes or milestones where possible (growth in programs, better retention, higher graduation rates, more students going to college, higher test scores, increased funding, etc.)

What makes this candidate unique from others in the profession? How has he or she gone above and beyond? Provide concrete examples over general descriptions.

Clarity & Conciseness

Can you sum up in one sentence why the nominee deserves recognition? Keep your writing focused and make every word count. Don't worry about adding details that don't speak to the candidate's qualifications for the award.

Is it easy for the reader to follow your train of thought and identify how every point addresses the criteria for the award? Keep the application organized; use bullet points if appropriate.

Explain achievements in plain language. Judges may not be as familiar with activities that are specific to your content area, program or CTSO. Try to eliminate or explain jargon where possible.

Professionalism

Proofread! Type your application in Microsoft Word or a program that will catch basic spelling and grammatical mistakes before copying into the online form. Then ask a peer or colleague to proofread your application. Two sets of eyes are better than one!

FFA Holds State Leadership Development Event Day

The North Dakota FFA State Leadership Development Event was scheduled on December 13, but the weather forced a post-postponement to January 19, 2023. The competition allowed students who had already qualified from district competition to prepare for the January event.

With over 300 students and advisors in attendance at the Bismarck Event Center from 49 chapters from across the state, the weather cooperated on January 19. More than 60 volunteers served as judges for the eight events that were offered. Students qualified for the National FFA Convention to be held in October in Indianapolis, Indiana.

North Dakota Advisor said, "Leadership Development Event day finds judges and volunteers in front of some of the best FFA members in their respective contests. Its so exciting to watch the students and advisors

State Director's Column

68th Legislative Assembly Update

We are currently one month into the 68th Legislative Session. The Department of Career and Technical Education is currently tracking 127 bills, most we are simply watching, but there are many that we are working in Committee and meeting rooms, for the benefit of Career and Technical Education and the students it serves. Below is a list of Legislative Bills we are spending most of our time on.



HB 1019 – NDCTE Appropriations Bill. The

Department has had multiple hearings in
relation to HB 1019. I am told they are very close to finalizing our bill, to be
considered by the full House Appropriations Committee and eventually the House
Chamber. So far, discussion has been very supportive of the funding asks.

HB 1032 – This creates a high-demand certificate scholarship, focusing on CDL and CNA training programs.

HB 1163 – This bill would create a Career and Technical Education graduation pathway. A Legislative Sub-Committee has been created to determine how to best amend the bill.

HB 1178 – This bill would allow Higher Education, Private/Parochial School, and/or Private Sector to be represented on a CTE Center Board.

HB 1199 – This is the fast-track bill, that would provide NDCTE with Loan Authority to carry out the CTE Capital Projects Program. This passed both the House Appropriations (1/18) and House Floor (1/20) unanimously and will now move to the Senate.

HB 1232 – This is a bill that would appropriate \$500,000 to NDCTE to add a virtual reality career exploration resource to our RUReadyND platform. This was amended to include an Emergency Clause and passed out of House Appropriations.

HB 1305 – A bill that amends the State Scholarship, to align with changes to Choice Ready

HB 1348 – A bill that amends CTE Center Governance, to address large CTE Center Boards and allow for a representative Board structure.

HB 1382 – A bill that would allow the State Scholarship to be used for Registered Apprenticeship expenses.

HB 1383 – A bill that provides an apprenticeship tax credit for employers, replicating the internship tax credit.

68th Legislative Assembly Continued

- HB 1398 A bill that requires computer science and cyber security to be taught in our Public Schools. The State Board for Career and Technical Education has agreed to support this bill.
- HB 1451 A bill that would increase the state scholarship to \$10,000, starting with the 2023 graduates.
- HB 1519 A bill that would appropriate \$1,000,000 to NDCTE, to grant out for UAS workforce training to a workforce training center serving NW North Dakota
- SB 2070 This bill will allow for teacher permits to be extended for an additional three years if an individual enrolls in a teacher preparation program. This has been amended to add four years (total of seven).
- SB 2122 This bill would codify how TrainND funds are allocated to the four regions. 50% would be allocated equally, 1 0% would be allocated by covered employment, 40% would be allocated based on enrollment of the previous biennium. An amendment will be introduced that would allow the State to study this issue.
- SB 2269 A bill that would move the authority over the Center for Distance Education from NDCTE to NDDPI. A number of amendments were submitted that would create a Governance structure for CDE.

As a CTE Champion, and a citizen of North Dakota, I ask you to be involved in the process. The Legislative process is transparent and, thanks to technology, can be accessed anywhere. The following link allows citizens to watch House of Representatives and Senate Floor Sessions and Committee Hearings; contact their local Legislators; search and track specific bills; and submit written and verbal testimony. A North Dakota login ID will need to be created to track bills and submit testimony. A login is not necessary to watch video of Floor Sessions or Committee Hearings.
