#### **Private Career Schools in North Dakota**

Hopefully you are aware that the ND Department of CTE has and continues to authorize all private career schools in the state so that they can legally operate. These schools are defined as private, vocational, technical, home study, business, professional, or other private schools or colleges offering educational credentials primarily to persons who have completed or terminated their secondary education or who are beyond the age of compulsory high school attendance, for attainment of educational, professional, or vocational objectives at a level no higher than the associate of applied science level. Some state professional boards have their own jurisdiction over their own professional schools of this type (such as in nursing, cosmetology, etc.), but many certificate-offering, post-secondary schools work with NDCTE to become authorized.

Through a yearly process of submitting documents to the agency, these schools operate in the state and offer professional certificates for hours of completion toward such jobs as massage therapy, welding, full stack engineering, electrician apprentice, etc. The aim of this statute of state law is to provide validity to these schools (in addition to them working toward gaining national accreditation) and primarily to protect the citizens and potential students of North Dakota from predatory or dubious businesses, which could provide a meaningless certificate or take money and provide nothing (i.e. fraudulent degree-factories). Most schools on the authorized list are in-state; however, out-of-state schools can and should apply.

# Enderlin FFA Leads Massive Volunteer Effort After Tornado Devastation

After a powerful EF-3 tornado struck the Enderlin, North Dakota area on June 20, the community was left reeling from the loss of life, destruction of property, and widespread damage to farms and homes. In the face of such devastation, the Enderlin FFA Chapter stepped up to lead a largescale volunteer effort to support recovery and cleanup efforts across the region.

Organized by Enderlin FFA, the response brought together more than 150 volunteers—including FFA members from Enderlin, Lisbon, Kindred, and Central Cass. These students worked alongside local farmers, first responders, and community members to clear dangerous debris, remove fallen trees, and prepare fields for the upcoming harvest.

"With so many farms impacted and harvest just around the corner, we knew how important it was to get to work," said Jocelyn Birklid, one of the student leaders from Enderlin FFA. "It wasn't about being asked—it was about showing up for our neighbors when they needed us most."

Volunteers used everything from drones to chainsaws to locate and remove storm debris. Local businesses and families supported the effort by providing tools, equipment, water, and meals to keep volunteers going throughout the day. The cleanup was a true demonstration of the FFA motto: *Living to Serve*.

Missy Sanford, a volunteer from Lisbon, shared, "We all come together, and that's the best part of a small community. No one hesitates to help."

Thanks to the leadership of Enderlin FFA and the outpouring of support from surrounding chapters and the broader community, progress toward recovery is well underway. It was a day of healing, hard work, and hope—proving that even in the face of tragedy, the spirit of service and unity can shine through.



# North Dakota Educators Dive into Engineering by Design Curriculum

Last week, Technology and Engineering educators from across North Dakota gathered for an immersive training session on the **Engineering by Design (EbD) Curriculum**. This invaluable project was funded by North Dakota Career and Technical Education, with expert trainers provided by the International Technology and Engineering Educators Association (ITEEA).

Teachers explored various facets of the EbD curriculum, gaining hands-on experience that they can directly bring back to their classrooms. Highlights included:

• **Coding with Micro Bits:** Learning foundational coding skills using MicroBits. A small device to help students learn basic coding skills.

 Structures & Cranes: Teams built cranes with limited supplies and tested them to failure, providing practical insights into structural engineering.
Solar Sprint Cars: Participants collaborated to build functional solar sprint cars.

Basic kits, generously donated by the **U.S. Army** (who also sponsors the National TSA Conference event and provides free kits to students nationwide), included a solar panel, motor, and gears. ITEEA supplemented these with boards, glue, and wheels. The challenge was to build for speed, leading to exciting testing and adjustments before the final race. Even Mother Nature seemed to approve, as the morning rain cleared just in time for the race!

A huge thank you goes out to the ITEEA trainers for a fantastic week of learning and to **Valley City State University** for hosting such a wonderful event. **Interested in EbD Curriculum?** Technology and Engineering educators who want to learn more about the EbD Curriculum are invited to attend a short session on Wednesday during PDC in August. # **State Director's Column**

If you are like me, you are watching intently what is occurring nationally concerning Career and Technical Education, the US Department of Education and Carl D. Perkins. My article this month is to provide an overview of what we know currently.

#### Transition of Carl D. Perkins from the US Department of Education to the US Department of Labor

As many of you saw in June, during the legal proceedings concerning the operations of the US Department of Labor, an Interagency Agreement (IIA) between the US Department of Labor and US Department of Education was disclosed. The IAA would transfer the administration of Career and Technical Education funding, specifically Carl D. Perkins, from the Department of Education to the Department of Labor. This agreement has been paused due to legal proceedings, but the State will continue to evaluate the impact if this does happen and keep you all posted on any updates.

#### **Administration's Budget Proposal**

The current Administration has provided its budget proposal which is being reviewed by Congress and will be acted on in the upcoming months. Congress does have the final say, as this is simply a proposal. Highlights specific to Career and Technical Education are as follows:

- The Carl D. Perkins Basic State Grant funding will be held level.
- Funding for national activities is reduced.
- The emphasis of funding will be on Middle School and High School CTE Programming.
- Post-Secondary Career and Technical Education funding would be eliminated.
- Post-Secondary Accountability Measures would be phased out.

#### **Carl D. Perkins Reauthorization**

Finally, there has been very initial discussion concerning the reauthorization of the Carl D. Perkins Act, therefore bringing forward Perkins VI. These are very initial conversations, with other large reauthorization bills in line in front of Perkins. I will continue to provide updates as information is made available.
