# ND Incorporates CareerViewXR's Virtual Reality Videos into RUReady.ND.gov

The North Dakota Department of Career and Technical Education (NDCTE) and the Career Resource Network (CRN) are excited to announce a groundbreaking initiative aimed at revolutionizing career exploration for students through our existing RUReady.ND.gov career exploration platform. Thanks to a funding commitment by the State of North Dakota's 68th



Legislative Assembly, we're bringing the engaging world of virtual reality (VR) career exploration to every middle and high school student across the state, completely free of charge. North Dakota students in grades 6-12 will now have access to virtual reality experiences that will help them make informed career decisions.

CareerViewXR is a cutting-edge immersive media and VR career exploration platform designed to give students a first-hand glimpse into various career paths by immersing them in 360-degree virtual tours and virtual reality video experiences. CareerViewXR was developed by North Dakota startup, Be More

Colorful, and consists of a growing library of immersive experiences featuring in-demand occupations filmed at employer locations around the state.

Unlike other VR platforms, CareerViewXR does not require the use of VR headsets. Students across the state will have the ease of exploring careers through a series of interactive web-based tours, whether on their laptops, tablets, phones, or other school-issued devices. Schools that have invested in VR hardware can also dive into the VR experience. For schools looking to obtain VR headset hardware, multiple funding opportunities are available, including Perkins, ESSER, and REAP funding.

CareerViewXR attended the ND Council of Educational Leaders conference in October and asked administrators to complete a needs assessment for your school. ## **State Director's Column**

## **2023 Special Legislative Session**

As you may have read or seen on the news, Governor Burgum called the Legislative Assembly to address the North Dakota Supreme Court decision that found SB2015 or the North Dakota Office of Management and Budget appropriations bill unconstitutional.

Prior to the Special Session beginning, Legislative Management reviewed SB2015 and drafted fourteen bills to address all the sections within SB2015. Legislative



Management also allowed Legislators to submit bills for consideration. A total of 29 bill drafts were submitted, with only one being approved to move forward to the Special Legislative Session. Another bill, impacting Income Tax, was introduced and adopted on the House of Representatives floor, so that also had a hearing. This brought a total of sixteen bills to be acted upon by the Special Legislative Session.

The Special Legislative Session convened on Monday, October 23<sup>rd</sup>. Two joint committees were created to hold public hearings. The two committees were a Joint Appropriations Committee and a Joint Policy Committee. Both committees were responsible for eight bills.

One of the bills was HB1543. HB1543 directly impacted Career and Technical Education as it included the \$26.5M that were to address inflationary costs related to the CTE Capital Projects Program. This funding was included in SB2015 and need to be addressed in the Special Legislative Session. It was heard by the Joint Appropriation Committee, slightly amended, and sent to both Chambers for approval, which occurred.

The special Legislative Session adjourned on Wednesday, October 25<sup>th</sup>, completing the work they were tasked to do.

## **Assistant Director's Corner**

## The Work Ahead—CTE and the Future of Work

This month I would like to share about our main speaker who was at the Fall 2023 Advance Career Technical Education (CTE) State Leadership Meeting in Baltimore on October 16<sup>th</sup>-18<sup>th</sup>.

Advance CTE is our national association of State CTE Directors and related professionals, equipping those leaders with knowledge and inspiration to move education forward. Our state and the American workforce is changing. CTE opens bold new paths for learners to achieve lifelong success, offering opportunities that align with all passions and pursuits.

Our keynote speaker was Chike Aguh, an education and workforce development innovator who is a former Chief Innovation Officer at the U.S. Department of Labor and currently a Senior Advisor for the Project on Workforce Harvard. Chike set the tone for the fall meeting early by sharing how his parents, first-generation immigrants to the United States, had CTE-connected careers, which paved the way for his own success which included serving the President of the United States. Chike knows that more remarkable stories like this are made possible because of the work that CTE leaders do.

His presentation explored the question: What world are we preparing our learners for, and how does Career Technical Education prepare them for it?

His message was clear – the world of work is changing dramatically and CTE needs to meet the challenge. Some changes have already happened, such as automation and remote work in industries ranging from loan administration to transportation. Other changes are yet to come, and they continue to profoundly change and, in some cases, put at risk jobs that Americans rely on.

The way CTE responds to these challenges, according to Chike, is by equipping learners with both "timeless" skills and "just in time" skills. These skills don't just make learners prepared for the workforce, they make them economically indispensable.

One resonating message from him is that "'Career Technical Education' is too small a term for what CTE leaders are doing and what they need to do". He applauded CTE leaders and educators for the work that they do every day, yet stressed the hard work that lies ahead for CTE in empowering the workforce of the future.
